## **Gas R&D Program Background**

- \$24 million annual budget to advance gas-related technology innovation and research
- Guided by California legislation, D.04-08-010, and CPUC resolutions
- Supports state energy policy
- Benefits gas ratepayers

• Supports collaboration and co-funding opportunities











## **Gas R&D Program Impact**

**\$318**<sup>+</sup> **million** invested to advance **301 projects** in California since 2004.

>70%
OF GAS R&D FUNDS

\$6.1+

23<sup>+</sup> PROJECTS

Invested in projects located in a disadvantaged community, low-income community, or both.

In private investment received by awardees after being selected for a Gas R&D Program award.

Informed codes, standards, proceedings, or protocols, providing ~\$65+ million per year in energy cost savings.

## Support Equitable, Safe, and Cost-Effective Decarbonization of California's Gas System

**Purpose:** Leverage data streams and fieldwork to understand gas end use, end users, and decarbonization and decommissioning pathways.

- Assesses conversion benefits & costs distributionally, informing equity improvements
- Facilitates uptake of alternatives to fossil gas
- Informs gas proceedings (e.g., R.20-01-007)
   and planning efforts (e.g., demand forecasting)





## Innovations for Cost-Effective Operation & Maintenance of Critical Infrastructure During the Gas Transition

**Purpose:** Advance less intrusive inspection, monitoring, and testing technologies for underground gas storage and gas transmission pipelines.

- Enables prompt intervention and proactive maintenance
- Reduces disruptions to gas operations and reliance on redundant infrastructure
- Reduces cost and safety burdens for vulnerable communities
- Aligns with efforts to streamline compliance with recent regulations to reduce costs while ensuring safety (R.20-01-007)





## Fuel-Flexible Distributed Power Generation


**Purpose:** Enable prime movers to use a single or mix of renewable fuels while meeting performance, cost, and low-emission targets.

- Ensures consistent generation with fuel diversification
- Enhances reliability, stability, and safety
- Optimizes costs using more advantageous fuels
- Reduces GHG and NOx emissions











## **Networked Geothermal District Heating**

**Purpose:** Evaluate feasibility of and advance technology for using geothermal resources in building district heating systems.

- Phase I: Study deeper geothermal resources (~1,500 meters) for district heating systems
- Phase II: Demonstrate drilling technology and leverage existing oil and gas wells as geothermal drilling sites

- Aligns with CPUC's Building Decarbonization Proceeding to reduces GHG emissions and reliance on fossil gas
- · Improves safety by replacing aging gas infrastructure
- · Encourages more stable utility costs
